WHEREAS, SENATOR ELLEN KARCHER HAS SPONSORED SENATE BILL 366 CONCERNING INCREASING FINES FOR VIOLATIONS OF O.P.M.A.; AND

WHEREAS, THE MAYOR AND BOROUGH COUNCIL OF THE BOROUGH OF JAMESBURG STRONGLY SUPPORTS THE PRINCIPLES AND NEED FOR OPENNESS AND TRANSPARENCY OF GOVERNMENT AND PUBLIC ACCESS TO GOVERNMENTAL RECORDS; AND

WHEREAS, THE MAYOR AND BOROUGH COUNCIL ALSO STRONGLY SUPPORTS EFFICIENCY OF GOVERNMENT AND THE NEED TO REDUCE THE RISK, COSTS, AND EXPENSES OF LITIGATION; AND

WHEREAS, SENATE BILL 1219 INCREASES FINES AND PENALTIES FOR ANY VIOLATION OF O.P.M.A. AND O.P.R.A. IN CONFLICT WITH N.J.S.A. 59:1-1, et. seq. AND IS OTHERWISE DISHARMONIOUS WITH PRINCIPLES OF GOOD GOVERNMENT IN THAT IT;

- 1. CREATES A CONFLICT WITH THE DEFINITION OF "MEETING" AND MAY CAUSE CONFUSION AMONG OFFICERS WHO STATUTORILY ARE REQUIRED TO BE PRESENT AT MEETINGS:
- 2. ADDS LANGUAGE, "ELECTRONIC MAIL, INSTANT MESSAGING, OR SIMILAR TECHNOLOGIES" WHICH IS UNNECESSARY IN LIGHT OF THE EXISTING ALL-INCLUSIVE LANGUAGE "OR BY MEANS OF COMMUNICATION EQUIPMENT" PERTAINING TO MEETINGS;
- 3. CHANGES THE 48 HOUR NOTICE REQUIREMENT TO A THREE BUSINESS DAY REQUIREMENT WHICH WILL FRUSTRATE THE ABILITY TO HAVE MEETINGS BECAUSE NEWSPAPERS NEED TIME TO PROCESS NOTICES;
- 4. PROVIDES FOR PUBLIC COMMENT AT ANY MEETING OF ANY PUBLIC BODY, WITH NOT LESS THAN FIVE MINUTES PER SPEAKER AND NOT LESS THAN ONE HOUR IN TOTAL AND IS UNDULY BURDENSOME;
- 5. REQUIRES THE SPECIFICATION OF THE BASIS FOR EXCLUDING THE PUBLIC FROM EXECUTIVE SESSIONS WHICH MAY LEAD TO CONFUSION, ADDED LITIGATION AND POTENTIAL EXPOSURE TO LIABILITY;
- 6. REGARDING MINUTES IS OVERLY BURDENSOME ON THE RESOURCES OF THE MUNICIPALITY AND MAY LEAD TO INCREASED EXPENDITURE OF PUBLIC FUNDS;
- 7. PROVIDES FOR UNILATERAL ATTORNEY'S FEES FOR THE COMPLAINANT, WHICH IS UNFAIR AND HAS THE EFFECT OF FRUSTRATING THE OPERATION OF LOCAL GOVERNMENT. ATTORNEY'S FEES SHOULD BE AVAILABLE TO BOTH PARTIES;
- 8. EXPANDING THE GOVERNMENT RECORDS COUNCIL TO INCLUDE O.P.M.A. WILL FURTHER BACKLOG AN ALREADY INUNDATED AGENCY AND PROLONG LITIGATION:
- 9. JEOPARDIZES THE CONFIDENTIALITY OF EXECUTIVE SESSIONS AND THE PURPOSE OF THIS EXCEPTION TO THE O.P.M.A.:
- 10. CHANGES THE "KNOWING AND WILLFUL" STANDARD TO "SUBSTANTIALLY" STANDARD, PLACING THE MUNICIPALITY AND ITS OFFICERS IN RISK OF LITIGATION IN CONFLICT WITH N.J.S.A. 59:1-1. et. seq. ;
- 11. INAPPROPRIATELY PROVIDES FOR LEGAL REPRESENTATION OF PRIVATE INDIVIDUALS AND PAYMENT FOR SAME WITH PUBLIC MONIES;
- 12. REGULATIONS AUTHORIZED BY THE PROPOSED NEW AGENCY ("OPEN GOVERNMENT COUNCIL") WOULD BE LIMITED IN APPLICABILITY AND MAY RESULT IN INCONSISTENT SUPERIOR COURT AND O.G.C. DECISIONS
- 13. REQUIRES A QUARTERLY REVIEW OF MINUTES AND RECORDINGS OF CLOSED SESSION ITEMS WHICH HAS THE POTENTIAL TO JEOPARDIZE CONFIDENTIALITY:
- 14. TAKES A STEP BACK IN THE ADVANCEMENT OF TECHNOLOGICAL TOOLS AVAILABLE TO PUBLIC BODIES TO PROPERLY ADVISE THE PUBLIC;
- 15. REQUIRES RECORDATION OF EXECUTIVE SESSIONS AT WHICH CONFIDENTIAL MATTERS ARE DISCUSSED;
- 16. IMPOSES ADDITIONAL BURDENS OF REQUIREMENTS UPON SUB-COMMITTEE MEETINGS;
- 17. REQUIRES THAT MINUTES BE AVAILABLE WITHIN FIVE (5) BUSINESS DAYS THEREBY CREATING UNDO HARDSHIP UPON THE OFFICE OF THE MUNICIPAL CLERK AND LIMITS RESOURCES OF THE MUNICIPALITY; AND

WHEREAS, SENATE BILL 1219 CONTINUES TO EXEMPT THE LEGISLATIVE BRANCH OF STATE GOVERNMENT FROM THE SAME REQUIREMENT THAT SENATE BILL 1219 WOULD IMPOSE ON MUNICIPALITIES, SCHOOL DISTRICTS AND AUTHORITIES; AND

WHEREAS, SENATE BILL 366 CHANGES THE "KNOWINGLY VIOLATES" STANDARD TO "KNOWING OR NEGLIGENTLY VIOLATES" STANDARD WHICH IS IN CONFLICT WITH N.J.S.A. 59:1-1

et. seq. AND IS OTHERWISE DISHARMONIOUS WITH THE PRINCIPLES OF GOOD GOVERNMENT IN THAT IT:

- 1. INCREASES TEN-FOLD THE FINES FOR VIOLATIONS OF THE STATUTE THUS SUBJECTING MUNICIPALITIES AND THEIR OFFICERS TO INCREASED COSTS AND RISKS OF EXPOSURE TO LITIGATION;
- 2. PROVIDES FOR UNILATERAL ATTORNEY'S FEES FOR THE COMPLAINANT, WHICH IS UNFAIR AND HAS THE EFFECT OF FRUSTRATING THE OPERATION OF LOCAL GOVERNMENT. ATTORNEYS FEES SHOULD BE AVAILABLE TO BOTH PARTIES;
- 3. INAPPROPRIATELY INCLUDES AUDIO AND VISUAL RECORDINGS OF MINUTES, PLACING AN UNDUE BURDEN ON MUNICIPALITIES TO MAKE AUDIO AND VISUAL RECORDINGS AVAILABLE TO THE PUBLIC ON THE SAME BASIS AS MINUTES:

NOW, THEREFORE, BE AND IT IS HEREBY RESOLVED, THAT THE MAYOR AND BOROUGH COUNCIL OF THE BOROUGH OF JAMESBURG, IN THE COUNTY OF MIDDLESEX, DOES HEREBY OPPOSE THE ADOPTION OF SENATE BILL 1219 AND SENATE BILL 366 FOR REASONS SET FORTH ABOVE AND FOR THE REASON THAT SAID BILLS WILL NOT POSITIVELY AFFECT THE PUBLIC'S ACCESS TO OPEN GOVERNMENT AND WILL LIKELY HAVE THE COUNTER-EFFECT OF FRUSTRATING THE OPERATION OF LOCAL GOVERNMENT; AND

RESOLUTION #152-05-10-06

RESOLUTION IN SUPPORT OF S-192, AUTHORIZING A COMPETITIVE SYSTEM-WIDE FRANCHISE FOR CERTAIN PROVIDERS OF CABLE TELEVISION SERVICE.

WHEREAS, THE NEW JERSEY STATE LEAGUE OF MUNICIPALITIES, AS WELL AS THE MAYOR AND BOROUGH COUNCIL OF THE BOROUGH OF JAMESBURG, HAVE BEEN CLOSELY MONITORING THE PROGRESS OF SENATE BILL 192, WHICH WOULD AUTHORIZE A COMPETITIVE SYSTEM-WIDE FRANCHISE FOR CERTAIN PROVIDERS OF CABLE TELEVISION SERVICES; AND

WHEREAS, THE NEW JERSEY STATE LEAGUE OF MUNICIPALITIES BELIEVES THAT MUNICIPALITIES WILL BENEFIT FROM MORE COMPETITION IN THE AREA OF CABLE TELEVISION SINCE COMPETITION SHOULD IMPROVE SERVICE AND LOWER RATES; AND

WHEREAS, THE FEDERAL COMMUNICATIONS COMMISSION HAS REPORTED THAT THE MONTHLY CABLE RATE IN MUNICIPALITIES WHERE THERE IS CABLE COMPETITION IS 15.7% LOWER THAN IN NON-COMPETITIVE MUNICIPALITIES, AND THE PRICE PER CHANNEL IS 27.2% LOWER; AND

WHEREAS, SENATE BILL S-192 REQUIRES AN APPLICANT FOR A SYSTEM-WIDE FRANCHISE TO ACCOMMODATE LOCAL MUNICIPALITIES BY, AMONG OTHER THINGS, PROVIDING TWO PEG CHANNELS, PROVIDING INTER-CONNECTION TO ALL OTHER CABLE COMPANIES, PROVIDING FREE BASIC SERVICE AND FREE INTERNET SERVICE TO MUNICIPAL INSTITUTIONS, PROVIDING EQUIPMENT AND TRAINING FOR ACCESS USERS; AND

WHEREAS, A REPRESENTATIVE OF VERIZON HAS MET WITH BOROUGH OFFICIALS TO DISCUSS WHAT BENEFITS THE CITIZENS OF JAMESBURG COULD REALIZE FROM A STATE WIDE VIDEO FRANCHISE; AND

COUNCIL MEMBER COMMITTEE REPORTS

EDUCATION COMMITTEE

Council member Carpenter reported on Board of Education, Library Board, and Patriotic Committee events.

POLICE COMMITTEE

Police Commissioner Jennings commended and reported on a drug enforcement activity in which all members of the Police Department were involved and netted 30 arrests. Also reported that the Flood Control Commission has reached out to F.E.M.A. and the N.J.D.E.P. regarding flood maps of the region. The SERV Center Committee is currently working on resolving a number of issues.

FINANCE AND BUDGETING COMMITTEE

Council member Kostbar had no finance report, however, in light of a recent Land Use Board matter, in which an applicant sought the approval of the Board to destroy an Historic home and build three homes on the involved property, Council member Kostbar spoke regarding the need for a density limitation and change to the Land Use ordinance to change the current R-75 zoning changed to R-100. Council member Longo, also a member of the Land Use Board, spoke regarding the need for amendment to the Land Use ordinances due to the most recent Master Plan as well as the need for a re-examination of the Master Plan. Council further discussed whether such an amendment can be done concurrently with the amendments for alignment with the Master Plan.

PERSONNEL/NEGOTIATIONS COMMITTEE & HOLIDAY EVENTS COMMITTEE

Council member Longo reported that the Police Committee has interviewed candidates for Special Police Officers. The applications will be reviewed for a recommendation to be made by the Personnel Committee. The fund-raiser dinner dance for the Deacon's Food Pantry will be held on May 19. Council member Longo also reported that Senator Inverso, Assemblyman Baroni, Assemblywoman Greenstein, and the Middlesex County Board of Chosen Freeholders have all been invited to attend and march in the annual Memorial Day parade. Further details of the parade were reported.

BUILDINGS, GROUNDS AND PARKS COMMITTEE & TECHNOLOGY COMMITTEE

Council member Maloney reported that a meeting was held with a representative from Verizon. They currently do not have plans to offer video services in Jamesburg but will keep the Borough's interest in the matter in mind. Council member Maloney attended the Comcast open house and reported that it was a very fascinating tour of their facilities. Also thanked Business Administrator Jawidzik for her diligence in locating a contractor to install the A.D.A. accessible bathroom at the Buckelew House. The Historical Association has informed Council member Maloney that the Association was unable to come to a consensus regarding the proposed amendment to the lease agreement with the Borough, however, they will re-consider the matter at their next meeting.

PUBLIC WORKS COMMITTEE

Council member Morales had no report.

Denise Jawidzik reported that surveys were sent out to 15 property owners regarding the making of John Street to a one-way street. Only two responded. One property owner felt the flow of traffic should be opposite of that proposed. Another felt the street should remain as is. Council discussed options to traffic flow and how this matter became a Council issue(a Land Use Board application). Council will visit the area and get a Police Department opinion as to the matter.

Mayor LaMantia reported on the "Jamesburg Revitalization Coalition" meeting that had a large turnout. The Federal Law Enforcement Officers Association will be holding an ID program at the Jamesburg Firehouse, where area children can be photographed and fingerprinted and the information will be stored on a CD for the parents to keep on file. Mayor LaMantia also reported that he attended the Tax Reform

Summit in Trenton and suggested residents contact their legislators urging movement on the matter of Property Tax Reform.
