Rob Czarneski – 189 Gatzmer Avenue: Mr. Czarneski read an article found in the Cranbury Press regarding the issue of the trucks hitting the bridge over on Gatzmer Avenue; he asked what the County is looking to do to improve the issue; Mayor Lowande responded that the County is looking to make new, bigger signs and should have them up by the end of August.

Mr. Czarneski also expressed concern with the issue of speeding and the lack of crossing guards on Gatzmer Avenue which he brought up to the Mayor and Council a year ago; he noted the County put the "Slow Down In Our Town" signs up but that does not seem to be working – he asked if there were any other avenues that could be sought out to ensure children will be safe walking along Gatzmer Avenue to get to school and their bus stops; Administrator Jawidzik responded and Mayor Lowande asked Mr. Czarneski to email her with what exactly his ideas are to get this situation addressed.
