ORDINANCE #04-17

AN ORDINANCE PROVIDING FOR THE ACQUISITION OF VARIOUS EQUIPMENT AND INFRASTRUCTURE IMPROVEMENTS AND APPROPRIATING THE SUM OF \$30,000 THEREFORE, AUTHORIZED IN AND BY THE BOROUGH OF JAMESBURG, IN THE COUNTY OF MIDDLESEX, NEW JERSEY

WHEREAS, the Borough of Jamesburg, in the County of Middlesex, New Jersey has determined to acquire various equipment and make various infrastructure improvements; and

WHEREAS, the Borough of Jamesburg has \$30,000 in the Capital Improvement Fund.

NOW THEREFORE, BE IT ORDAINED and enacted by the Mayor and Council of the Borough of Jamesburg, County of Middlesex, New Jersey, that:

SECTION 1. The purchase described in Section 2 of this ordinance is hereby authorized as a General Capital purchase to be undertaken in and by the Borough of Jamesburg, County of Middlesex, New Jersey.

SECTION 2. The acquisition hereby authorized to be undertaken consists of the purchase of various equipment and infrastructure improvements including but not limited to:

- a. Any capital equipment so determined as to be necessary including but not limited to, vehicles, computers, printers, computer equipment and software, municipal building upgrades, public works equipment, police equipment, together with all items necessary, incidental or appurtenant thereto.
- SECTION 3. The 2017 General Capital Budget of the Borough of Jamesburg will conform to the provisions of this ordinance
- SECTION 4. All ordinances or parts of ordinances inconsistent with the terms of this ordinance be and the same are hereby repealed to the extent of their inconsistency
- SECTION 5. This ordinance shall take effect 10 days after the first publication thereof after final adoption, as provided by law.

Without the budget, the DPW, Police and Borough Hall would not be up and running. Administrator Frueh responded that the budget was published in the paper. The Borough also is donating \$10,000 to the First Aid Squad this year.

Alan Brown – 111A Indigo Plaza, Monroe Township – Mr. Brown is a member of American Legion Post 127. He explained that after 13 years of running the Memorial Day parade, he will be stepping down and handing it over to the Borough. He is no cannot continue to do it on his own. Mr.. Brown will hand over all records to the town and help out where needed to keep the parade going.

<u>Thomas Emens – 62</u> West Railroad Ave. – Thomas was invited to speak by Council President Rutsky and Council Member Ludas. He spoke of the Ecology for Manalapan Brook. There is lots of wildlife living along the brook. Clearing away the blockages has been successful. Along with the wildlife there is a large diversity of birds and plant species. Having a walking trail put in place will have minimal impact on the wildlife in the area.

<u>Chief James Craparotta -</u> Chief of Police welcomed new Police Dispatcher Sunny Worden. She will be taking the place of Robert Bitterman. Mr. Bitterman has been with us for 11 years and will be moving out of the State in May. He will be training Miss. Worden. He also welcomed new Class II Special Officers Raymond Durski and Donald Miller. We received many applications and held 11 interviews. - 4. That minutes of the executive session shall be prepared and maintained by the Borough Clerk, and that such minutes shall be made public at such time as the need for confidentiality no longer exists, pursuant to direction from the Borough Attorney.
- 5. That formal action on any of the matters discussed in the executive session may only be taken during the open public portion of a meeting of the Mayor and Borough Council.
- 6. That, following the conclusion of this executive session (i.e., when the Mayor and Council re-convene the open portion of the meeting), action may be taken in public by the Mayor and Borough Council upon any of the matters discussed during this executive session.

FINANCE COMMITTEE Council Member Rampacek

EDUCATION COMMITTEE Council Member Czarneski

Council Member Czarneski reported that she attended the Board of Education meeting held on march 16th. Superintendent Brian Betze reported the following: The budget was discussed and approved to be submitted to the County for their approval and under the 2% cap. The final budget will be presented to the public in April. Community service requirements for 5-8 graders were discussed with a highlight on some of the activities that some students performed to fulfill their obligation. Sustainability projects will be worked into Earth Day/Green Day this year. QSAC performed site visit on March 9th and met with Administrators to ensure the district is up to speed and where it needs to be; of the 5 areas concentrated on, the district only fell short in 1 area. DonorsChoose.org provides teachers with educational materials and grants. Burlington Coat Factory collaborated with DonorsChoose.org and chose our district as a recipient for a \$10,000 donation via grant which will be used to purchase Google Chromebooks for the students. The suicide prevention policies and regulations that were discussed at the February meeting were approved by the Board. The resignation of Sal Brucato was accepted by the Board and the Board thanked Sal for his years of service.

Lastly, a presentation was made by Angela Celeste the manager of a NJ Jr. Achievement Biz Town for the Board and the public on how their organization works with teachers to provide students with

learning the importance of work readiness and financial literacy. This is a 12 week/12 lesson in school program and ends with a field trip to their center in Edison.

I would also like to thank Danielle Tanzi, Violations Clerk, for her years of service to the town. We wish her well in her new endeavor. Her replacement will begin in June. A SERV meeting was held April 10th. We met with the new County Director, Kelly, and Pauline Simms.

Environmental Report: The path entrance will be on Church Street. Entrance area will be cleaned up, weeded and trimmed. The path will be cleared to gravel soil (county regulations), no mulch will be used along the path route (county regulations). Existing fallen logs will be used to outline the path. There will be no construction (county regulations) or structures such as bridges, ramps, etc. All existing natural materials will be utilized for a welcome sign and tree identification signage, which I am assigning to the Eagle Scouts. Appropriate floral paintings will be placed at the entrance area. Target date is to be determined. Clean up to begin sometime in May. Completion target date is late August, as this will be an educational path for our student population.
