One Portable Fire Extinguisher shall be provided, it shall be rated residential use and of an ABC type, and NO larger than 10 lbs. and hung no higher than 5' off the floor in the kitchen within the means of egress to the exterior.

FEES: shall be based upon the amount of time remaining before change of occupant

More than 10 business days prior to change of occupant- \$45.00

4 to 10 business days prior to change of occupant- \$90.00

Less than 4 business days prior to change of occupant- \$161.00

CERTIFICATION OF SMOKE DETECTOR, CARBON
MONOXIDE & PORTABLE FIRE EXTINGUISHER
GUIDELINES

Upon receipt of completed application for a Certificate of Smoke Detector, Carbon Monoxide & Fire Extinguisher Compliance, the Jamesburg Fire Marshal's Office will make contact with either the applicant or the authorized agent that is supplied to us on the application, within a reasonable time frame, depending upon the estimated date of closing that is supplied to our office from the applicant. At this time the Jamesburg Fire Marshal's office will set an appointment to perform the inspection.

(Inspections are mostly scheduled for evening hours or Saturdays)

Upon completion and passing of inspection a Certificate of Compliance will be issued by the inspector.

Upon completion of the testing of the Smoke Alarms and/or the Carbon Monoxide Alarm, if there is a failure of such inspection, another inspection will have to be rescheduled and another fee,

(EQUAL TO THE INITIAL FEE) must be paid before a reinspection will be performed.

EFFECTIVE JANUARY 1, 2019

TEN YEAR SEALED BATTERY-POWERED SINGLE STATION SMOKE ALARMS SHALL BE INSTALLED AND SHALL BE LISTED IN ACCORDANCE WITH ANSI/UL 217. HOWEVER, A/C POWERED SINGLE STATION OR MULTIPLE-STATION ALARMS INSTALLED AS PART OF THE ORIGINAL CONSTRUCTION OR REHABILITATION PROJECT SHALL NOT BE REPLACED WITH BATTERY POWERED SMOKE ALARMS.

PLACEMENT OF ALARMS

Every floor of a dwelling **MUST** have at least one (1) operating Smoke Alarm.

All Fire protection systems, (smoke detectors) that were installed in compliance with any law, ordinance or order, shall be maintained in an operative condition at all times.

(ex. If smoke detectors were installed hard wired they must be maintained hardwired at all times)

A Smoke Alarm shall **not** be within five (5) feet of a kitchen area.

A Smoke Alarm shall **not** be within the radius of a ceiling fan's blades.

A Smoke Alarm shall **not** be mounted above an installed drop ceiling.

1-(one) Carbon Monoxide Alarm is required within 10 feet of any sleeping areas. And may be the plug-in style.
